Virtual and augmented reality (VR and AR) technology is being adopted in radiology. On the patient side, 3D medical imaging from the patient is being used for patient education about their disease or procedure.

For radiologists or other specialists, VR is being used to review complex anatomy in a virtual 3D/4D environment. This includes reviewing congenital heart disease 3D datasets and brain imaging prior to surgical interventions.

Legislature and Radiology

A big topic in our radiology world lately is state licensure. As most states are working hard towards either getting licensure approval or have a committee started to be working educating on radiologic technologist on the importance of it; there are still a handful that are not doing that and/or terminated their radiologic imaging and radiation therapy board of examiners such as Tennessee. On April 28, 2023, the governor of Tennessee decided to pass a bill not only terminating board members but have replaced them with just a generalized medical board who will then make the decisions on handing out limited scope licensures certificates. This new board will also get to establish qualifications for educational course requirements and the selections of one or more examinations to be utilized as division's limited certification examination and prerequisites examination. The new bill will affect radiologic technologist moving each license to Tennessee Department Division Health of Health-Related Boards. Not only is it affecting us technologist patients. patients Tennessee will be getting inadequate imaging which will then result in misdiagnosis or in some cases even a cancer undetected. Another state debating some changes very close to us here is South Dakota. In Senate Bill 175, it states that it would allow a physician assistant who has completed 2.080 practice hours, to practice without a collaborative agreement in the emergency department of a rural healthcare facility and in multiple primary care areas. Once the physician assistant has met the requirements they would be allowed to perform many medical procedures and be able to take xrays and perform radiologic procedures. This is still in the works and the Dakota Radiologic Society opposes the bill that has been presented.
